Jacob Harper 1752-1826, son of Philip Harper

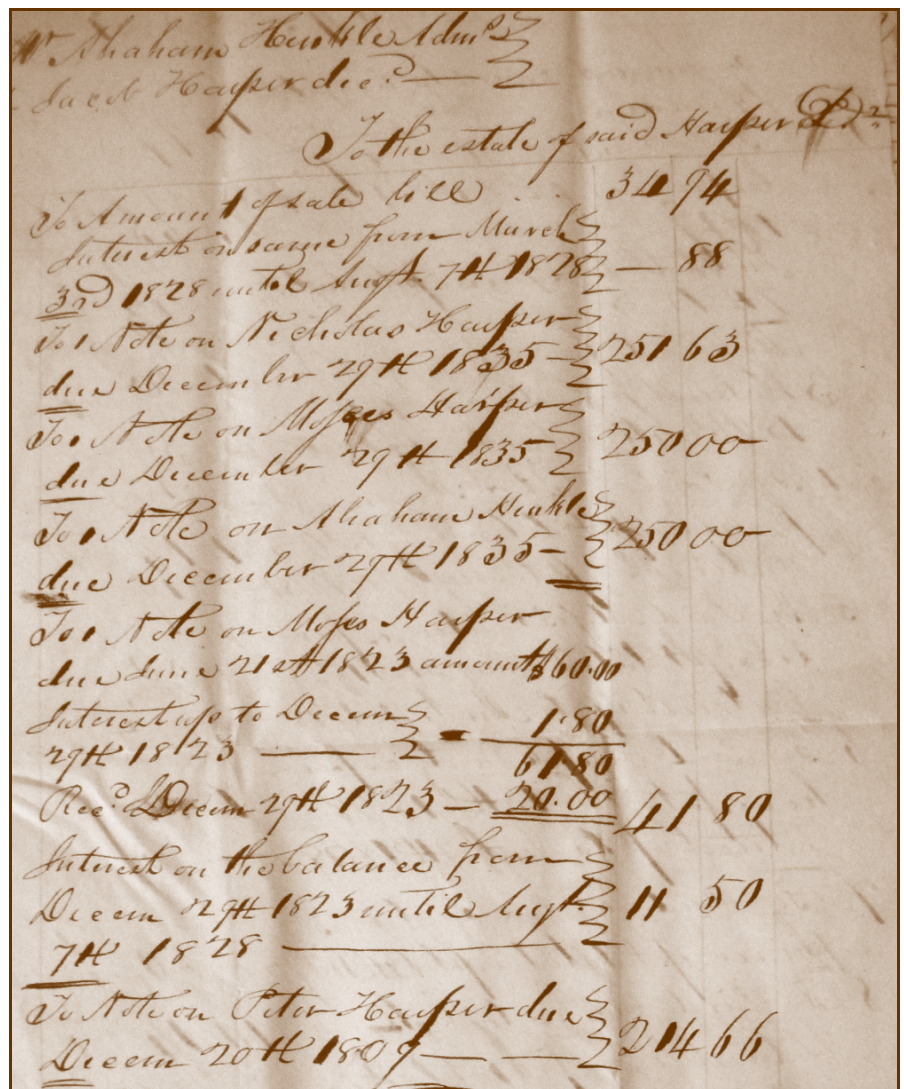
While at the Pendleton County Courthouse a couple of years ago, I managed to locate an *original* probate record of Jacob Harper's. Apparently, he lent money to several of his sons and son-in-law, and these are listed. Although there is no official record of his death, his

gravestone reads, "J.H. Dec. No. 2, 1826." This is interpreted as "Jacob Harper, deceased Nov. 2, 1826." This date is consistent with his estate sale being recorded 4 Apr 1827. Family legend tells that he was killed by a "widow maker" - a tree limb that fell on him while felling a tree - at the age of 74 years!

- Thomas "Tom" Rugguri, Jr., grandson-in-law of 5th Child, Seymour Harper, passed away May 1, 2019.

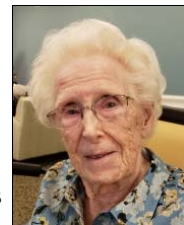

(Florence and Jeremiah were deceased by then, and Gettie Lee was expecting her first child.) After the weighing, they found that the boys averaged 210 lbs, and the girls 160 lbs. each.

The inestimable Shirley Yokum once again won as "Oldest Harper at the Reunion" last year, and she turned 100 years young on January 2nd of this year.

A close second, Irene Velma (Kisamore) Nester, turns 100 on May 27, 2020.

A Civil War Story

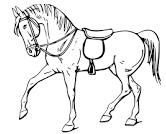

During the Civil War, my father, David Andrew Harper, kept the Union army informed as to the location of Rebel troops, and acted as a guide for the Union soldiers when they would march through the vicinity in which he resided [Braxton Co., WV]. The Rebel forces considered my father a spy for the Union Army, and twice captured him - but both times he escaped. After his 2nd escape, he came home thinking he would get a night's sleep and then leave - but his sleep was disturbed by a dream that six Rebel soldiers marched him out into the yard and shot him. He got up and went up against the hill, and slept there the rest of the night. The next morning, he left for Parkersburg. That night, six Rebel soldiers pushed the door open to his house, went in, and searched for him. His dream probably saved his life.

As a youth, he was involved in 4-H and FFA, and raised sheep and cattle. After graduation from Circleville High School, he earned a B.S. Degree (Jan 1965), and M.S. Degree (Jun 1966) in Animal Science at West Virginia University. During his career, he was appointed to three terms on the USDA National Wildlife Advisory Committee. He also received seven appointments from the U.S. Secretary of Agriculture. Serving as a director in the National Cattlemen's Association, he was also appointed to the National Farm Bureau Sheep Advisory Committee, and served as National Chairman for one term. Joe will be sadly missed by all who knew him. Friends from North Canton, OH had this to say: "Seneca Rocks will never be the same. Whenever we arrived, all we had to do was find Joe. His wide, dimply grin (and, sometimes, dangling cigar) assured us that we were home."
- Byron "Bud" Bland, Jr. - was a US Navy veteran of World War II. He was a member of Potomac Highlands VFW Post 6454. He was a Teacher and Principal at Seneca Rocks Elementary School for 35 years and retired in 1988. He was a member of the Retired School Personnel Association. He was on the Board of Directors of Upper Potomac Agency on Aging, the Pendleton County Senior and Family Services and Pendleton Manor Nursing Home. He was a member of Seneca Rocks Presbyterian Church and the Gidions International. He was a member of Spruce Mountain Ruritan Club and was a board member of the Grant County Bank in Riverton, WV. He leaves three sisters: Shirley Yokum of Seneca Rocks, WV, Judith Sponaule of Knoxville, TN, Billie Tubaugh of Des Moines, Iowa; one daughter: Deborah Judy and husband Roy Lee of Circleville, WV, and two sons, Michael C. Bland and wife Shirley of Keyser, WV, and Ronald L. Bland of Onego, WV.
- Thomas L. Rugguri, Jr. - 85, of Reisterstown, MD, passed away on Wednesday, May 1, 2019, at Gilchrist Hospice in Towson, MD. Born on May 29, 1933, in Baltimore, MD, he was the

Coronavirus Crisis - Weathering the Storm

From Carol Cooper: Hope all is going well for you. We are home bodies due to our age and the virus. Hope the warmer weather puts an end to it but no one really knows for sure. Our malls and restaurants are closing so the only shopping is online and groceries. Good luck finding toilet paper and paper towels. What did we do before toilet paper?

Marsha's reply: I hear ya! I've self-quarantined for at least the next several weeks. Went out the middle of last week and stocked up on food, disinfectant, toilet paper, and paper towels.

Oh, and you shouldn't have asked what we did before toilet paper - that's created a mental image I'll have trouble getting rid of! LOL

Her reply: Sears Roebuck catalog was always in the outhouse at my grandpa's in Michigan. We hated visiting him especially in the winter. Take care, too!

From Rick & Patty Harper: We are in Punta Arenas, Chile, aboard the HAL ship Zaandam. Just a heads-up that our attendance at this year's family reunion probably won't happen with all that is transpiring worldwide. Our ship is prohibited from docking (no known illnesses), so we may have to walk/drive/motorcycle back to the states. Thank goodness for the PanAmerican Highway.

Marsha's reply: Oh no!!!! I can't believe you got stuck in this!! I'm so sorry. This is a whole lot of craziness. The State of Maryland has basically been shut down. Libraries, schools, restaurants, bars, gyms, etc. have all been ordered closed by the governor. And no groups of over 50 people are allowed. (I find this unsettling on a "...abridging the right of the people to assemble peaceably" level.) Not sure what's going to happen with the Reunion since we clearly have more than 50 attendees, not to mention the problems of travel for lots of folks. Buzz and I discussed today and decided to play it by ear, and post a decision on the website when we get closer to the time.

I'm working on a mental picture and you and Patty with your thumbs out, waiting on the side of the PanAmerican Highway!

His reply: We are all well, the entire ship having passed medical examinations without indications of virus. Your point regarding peaceable assembly is spot on. When I heard Justin Trudeau tell Canadians to return home, the hair on the back of my neck raised. We are eating gourmet food, cruising the coast of Chile, probably safer than anywhere else on the planet. We visited Iguazu Falls, where malaria, dengue fever, chikunguya (sp) and yellow fever are

endemic. We wished that we could have stayed in the jungle, but we always bounce. The Falklands were amazing, and we kayaked in the Straits of Magellan with humpbacks, Magellan penguins and dolphins.

This trip I planned in November ahead of the virus, but we estimated our risk/reward was greater on the cruise. Of course, travel is in my blood, right? If we are allowed ashore, Patty and I will buy a motorcycle and shoot the Darien Gap. We actually prefer Mexico as a vacation spot. Peace and good wishes to all. -Rick "Horatio Hornblower" Harper, at anchor in Santiago, Chile

March 24: "Thanks for the update, stay healthy, stay positive. Our best wishes go out to you and all our family. John our eldest has taken a role with the Yurok tribe to support relief and food efforts in Humboldt County,

Mari, Patty's sister, is aboard still, even though she was scheduled to disembark in Santiago, Chile. We are under lockdown, not allowed out of our staterooms, but we are delighted to have an ocean view. Last night we completed the deep water crossing from Santiago to Lima, across the Nazca trench. We have been at sea since our March 14th departure from Punta Arenas, Chile.

Yesterday, we had a general alarm sound, the result of a small fire aboard in the laundry room. Our lockdown is the result of an increase in passengers and crew reporting an increase in flu-like symptoms. Patty, Mari and I continue to feel hale and hearty, although we miss access to fresh air during this quarantine.

The Rotterdam is steaming towards us and we are expected to rendezvous off Panama. They are bringing a full medical team and supplies to further replenish our stores. If tests indicate the presence of Covid-19, we will enjoy an extended stay aboard. Today, many passengers will become 'shellbacks', as we cross the equator. News re the efficacy of hydroxychloroquine is heartening, especially for hard hit regions like New York and Washington state.

Our ration of two bottles of wine per day and the fresh deck of Holland America playing cards ameliorate the boredom, as does chronicling our adventures. Holland America Line, our captain Ane Smit, the crew and the passengers have conducted themselves with grace and compassion."

Marsha's reply: Day 14 of Self-Quarantine - Finally went out in the car today after 2 weeks. (In my 50 years of driving, I think that's the longest time I've ever gone without being behind the wheel. It was a little weird. Seemed like I was going soooo fast. Ha ha. I've been used to my 3 mph walks with a neighbor for the last 14 days.

Just drove around to see the empty parking lots at

the shopping center and the mall, and then to see this beautiful field of daffodils that blooms every year on the wide median strip on Rt. 40.

After 1/2 hr., I was ready to go home! I'm kinda enjoying this slower, quieter lifestyle.

One thing I was amazed at - how many stores are using the "groceries" loophole to stay open. Like the regular discount stores who happen to have a few cans of food on the shelves. Seriously?

The Governor shut down all daycare centers, effective tomorrow. Whoa, what are all the working parents going to do with their kids?

Numbers of infected people rose sharply in Maryland today. When they tell us that we're in the calm before the storm... it's a little unsettling.

Hope you're enjoying your 2 bottles of wine per day!

His reply: Wonderful hearing you're out and about. Driving after sailing is an odd vibe, so I can relate- it does feel fast.

After our Wednesday night covert operation to acquire critical medical supplies off Ecuador, last night we onboarded a medical team and more supplies in a blue-water exchange with the Rotterdam. Today, the two ships are sailing together for anchorage and a public exchange of stores, under the watchful gaze of Panamanian authorities.

We are well, wearing masks constantly, and still confined to our quarters. HAL has reduced our food and grog to school cafeteria levels - we do not prefer white flour and baked goods, rice and barley. Other than that first-world complaint, we pass our time pleasantly chatting with Mari, and our children.

Today, the Captain will reportedly have an announcement from HAL regarding our destination: Honduras is lovely in Spring, we hear. If we hear anything substantive, we'll let you know. -Bond, James Bond

My reply: I saw some TV coverage of your ships off the coast of Florida. Can you land?

His reply: Thanks, we're on the Rotterdam, waiting for our sister ship Zaandam to complete disembarkation. We were transferred here because we were healthy and fit enough to jump across the gap to the tender., at night, in swelling seas - whew.

We traveled together, law of friends and mariners, we are waiting to be docked. Thanks, cousin. Next adventure is the journey home.

From Marsha's non-Harper cousin in Laramie, Wyoming:

ming: We are definitely aware of the situation and although we don't have mandatory stay-at-home, it is being strongly encouraged. In other words go out as little as possible and only for necessities. I think we only had 166 confirmed cases in the State yesterday. but it goes up each day. We also have next to no test kits so very few people are being tested

unless they are sick enough to be hospitalized. A number of friends and relatives have had illnesses that could have been the virus, but they were not able to get tested because of the short supply. This means the number of cases is very much understated. Since my wife and I are in the high risk age, 79 and 80 respectively, only I leave the house. She has a history of respiratory problems and has had pneumonia in the past, so she stays put. I will be wearing a face mask from today on when I go out, but not an N95 type. Our peak is predicted to be in May and our only upside is that there are only about 550,000 people in Wyoming and many are in very rural settings. Cheyenne and Casper are our two largest towns with about 60,000 people each. The other side of that is that we don't have many hospital beds in the state and they will be overwhelmed if things get really bad.

From Reece & Marie Harper, Buford, Georgia:

I have now retired. Last June 1, 2019, Trench Shoring Services sold their family owned business to a hedge fund company in California. I had worked for them for 20 years and we were a very customer oriented business. We always concentrated on service and satisfaction and making the customer as our top priority. Within two weeks, I could see that none of that was the way of business for Trench Plate Rental Co., and I knew I was not going to be a good fit. After a 3 week struggle, they finally sent me a COBRA letter. Their layers of paper work is too much for me!!

I went home to Elko, NV that month for my 50th High School Reunion but, on the last day, found I was not doing well. I went to the Elko Hospital and they immediately made arrangements for me to go to Salt Lake City or Reno. Since I have a lot of relatives in Reno, I choose Renown Medical Center and they found that I had a Upper GI Bleed and took care of it. It was a long trip back to Atlanta, but we made it. Upon returning home, It was evident that I was not going to be able to return to work, so I retired!!

Marie and I have decided we are no longer at the age where we will be doing any more long distance trips. Dad is still at the Senior Manor Center in Elko and he fully understands. I now communicate via letters and the phone when possible. I have learned (since Mom passed away) that Dad hates to talk on the phone. He is doing very well and will be 95 this May!!

After retirement, I have lots of time on my hands but this new virus keeps Marie and I at home all of the time. We did a reverse mortgage on our house, so I no longer have a mortgage to pay and that helps a lot. Along with several other changes in our lives, we are settled in and very happy.

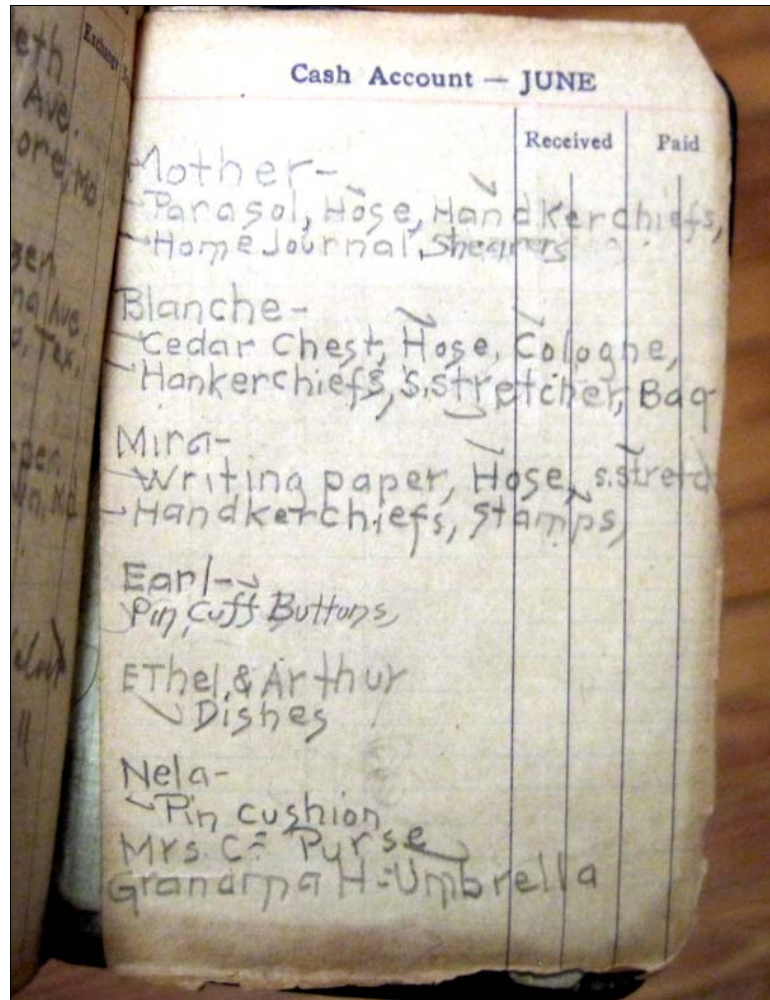
